

**Qualcomm Incorporated**  
**Equity Compensation Plan Information as of September 28, 2014**

Our equity plans are part of a broad-based, long-term retention program that is intended to attract and retain talented employees and directors and align stockholder and employee interests.

The 2006 Long-Term Incentive Plan (the 2006 Plan) was adopted during the second quarter of fiscal 2006 and replaced the 2001 Stock Option Plan and the 2001 Non-Employee Directors' Stock Option Plan and their predecessor plans (the Prior Plans). The 2006 Plan provides for the grant of incentive and non-qualified stock options, restricted stock units (RSUs), stock appreciation rights, restricted stock, performance stock units (PSUs) and other share-based awards and is the source of shares issued under the Non-Qualified Deferred Compensation Plan (NQDCP). The shares authorized under the 2006 Plan were approximately 573,284,000 at September 28, 2014. The share reserve remaining under the 2006 Plan was approximately 226,754,000 at September 28, 2014. Shares subject to any option under a Prior Plan that is terminated or canceled (but not an option under a Prior Plan that expires) following the date that the 2006 Plan was approved by stockholders, and shares that are subject to an award under the NQDCP and are returned to the Company because they fail to vest, will again become available for grant under the 2006 Plan. The Board of Directors of the Company may amend or terminate the 2006 Plan at any time. Certain amendments, including an increase in the share reserve, require stockholder approval. The Board of Directors may grant share-based awards to selected employees, directors and consultants to the Company to purchase shares of the Company's common stock at a price not less than the fair market value of the stock at the date of grant. Certain share-based awards include dividend-equivalent rights. Share-based awards vest over periods not exceeding five years. Options are exercisable for up to ten years from the grant date.

The Company did not grant options to the named executive officers during the twelve months ended September 28, 2014.

The Company granted approximately 341,000 PSUs to the named executive officers during the twelve months ended September 28, 2014. These PSUs vest over the respective service period of three years from the date of grant based on the attainment of certain total stockholder return performance measures and the named executive officer's continued service through the vest date.

The Company granted approximately 1,065,000 performance RSUs to the named executive officers during the twelve months ended September 28, 2014. These performance RSUs vest over a service period of five years from the date of grant based on the attainment of certain financial performance measures of the Company and the named executive officers' continued service. Approximately 698,000 performance RSUs vest in equal installments on the third, fourth and fifth anniversaries of the date of grant, and approximately 367,000 performance RSUs vest annually in five equal installments with the first vesting on May 5, 2015.

The Company granted approximately 687,000 RSUs to the named executive officers during the twelve months ended September 28, 2014. Approximately 275,000 RSUs vest over a service period of five years from the date of grant, vesting in equal installments on the third, fourth and fifth anniversaries of the date of grant, and approximately 412,000 RSUs vest annually in five equal installments with the first vesting on December 12, 2014.
